The Committees shall invite applications from the desirous doctors who meet the following eligibility conditions for such appointment by way of lateral entry:-

Such Senior Consultant/Consultant after joining in the Medical College shall be called as "Designate Professor" and on completion of 03 years experience in the capacity of Designate Professor, such person shall be designated as Professor.</p> <p>Provided that in case of research publications published before 5th June, 2017, first/second author shall also be considered in each of the above two categories.</p>
Associate Professor	<p>One time absorption by way of lateral entry from:-</p> <p>a) Government Medical Colleges by selection from amongst persons having a minimum of 09 years teaching experience, out of which four years should be as Assistant Professor as a full time faculty member in the concerned discipline in a medical college with minimum of two original research publications in indexed/national journals accepted/published as first/corresponding author.</p> <p style="text-align: center;">Or</p> <p>b) By selection from Health Department from amongst the Senior Consultants/ Consultants possessing a post graduate medical degree in the relevant subject and his/her working in the concerned specialty in a minimum 300 bedded hospital and having more than 10 years service, with two original research publications in indexed/national journals as first/ corresponding author.</p> <p>Provided that in case of research publications published before 5th June, 2017, first/second author shall also be considered in each of the above two categories.</p>

The Committees shall adopt the following criteria for making selections:-

i)	For Teaching experience/ Minimum required Service	60 Points (30 points for minimum required teaching experience or minimum required service as Senior Consultant/ Consultant service (in case of doctors from Health Department) for the post and 03 points for every additional year, subject to a maximum of 30 points).

(i)	For Research Publications	30 Points (15 points for required number of publications and 03 points for every additional publication, subject to a maximum of 15 points)
(ii)	For Higher qualification (DM/MCH only)	10 points

The applications to be invited from the desirous candidates shall be accompanied with the following documents in addition to the other documents as required:-

- i. NOC from the concerned Head of the Department and Principal Government Medical College, Srinagar/Jammu in respect of faculty members of these institutions seeking absorption by way of lateral entry in the new Medical Colleges.
- ii. NOC from Director, Health Services, Kashmir/Jammu in respect of Senior Consultants/Consultants seeking absorption by way of lateral entry in the new Medical Colleges.
- iii. Affidavit from 1st Class Magistrate to the effect that once appointed in the new Government Medical College shall not claim transfer to parent college/ parent department.
- iv. Relevant experience certificate from Head of the Institution in case of faculty members and Head of the Department in case of Senior Consultant/ Consultants, as the case may be, for the post for which application is being submitted.

While making selections, if there is a tie in score between two or more candidates, the candidate having secured maximum points in teaching experience/length of service as Senior Consultant/ Consultants, shall get preference. In cases where the candidates secure similar score on this account, then the candidate having maximum points in research publications shall get preference.

After making selections, the Committees shall forward the select lists to the Administrative Department for issuance of appointment orders, with the approval of the competent authority.

Applications are invited from the eligible candidates working as faculty members in Medical Colleges and as Senior Consultants/ Consultants in the Department of Health, Jammu, Kashmir for one time absorption by way of lateral entry as faculty members in Government Medical College against the posts of Professors and Associate Professors as per the following eligibility conditions.

Such Senior Consultant/Consultant after joining in the Medical College shall be called as "Designate Professor" and on completion of 03 years experience in the capacity of Designate Professor, such person shall be designated as Professor.</p> <p>Provided that in case of research publications published before 5th June, 2017, first/second author shall also be considered in each of the above two categories.</p>
Associate Professor	<p>One time absorption by way of lateral entry from:-</p> <p>a) Government Medical Colleges by selection from amongst</p>

persons having a minimum of 02 years teaching experience, out of which four years should be as Assistant Professor as a full time faculty member in the concerned discipline in a medical college with minimum of two original research publications in indexed national journals accepted/published as first corresponding author

Or

b) By selection from Health Department from amongst the Senior Consultants/ Consultants possessing a post graduate medical degree in the relevant subject and his/her working in the concerned specialty in a minimum 300 bedded hospital and having more than 10 years service, with two original research publications in indexed national journals as first corresponding author

Provided that in case of research publications published before 5th June, 2017, first/second author shall also be considered in each of the above two categories

The selection criteria for these posts shall be as under:-

i)	For Teaching experience/ Minimum required Service	60 Points (30 points for minimum required teaching experience or minimum required service as Senior Consultant/ Consultant service (in case of doctors from Health Department) for the post and 03 points for every additional year, subject to a maximum of 30 points).
ii)	For Research Publications	30 Points (15 points for required number of publications and 03 points for every additional publication, subject to a maximum of 15 points).
iii)	For Higher qualification (DM/MCH only)	10 points

The selection of the candidates for such posts shall be made by the respective Selection Committees constituted by the Government for the purpose vide Government Order No. 53-HME of 2019 dated 16.01.2019.

1. MBBS Degree and MCI Registration Certificate
2. Post-Graduate Degree and MCI Registration Certificate
3. Higher qualification Certificate (DM/MCH only).
4. Professional Publications, published in indexed/ national journals, as prescribed.
5. Date of birth Certificate
6. Permanent Residence Certificate (PRC).

In addition to above, the application forms shall be accompanied with the following documents:-

- i. NOC from the concerned Head of the Department and Principal Government Medical College, Srinagar/Jammu in respect of faculty members of these institutions seeking absorption by way of lateral entry in the new Medical Colleges.
- ii. NOC from Director, Health Services, Kashmir/Jammu in respect of Senior Consultants/Consultants seeking absorption by way of lateral entry in the new Medical Colleges.
- iii. Affidavit from 1st Class Magistrate to the effect that once appointed in the new Government Medical College shall not claim transfer to parent college/ parent department.
- iv. Relevant experience certificate from Head of the Institution in case of faculty members and Head of the Department in case of Senior Consultant/ Consultants, as the case may be, for the post for which application is being submitted.

In case of any dispute, the decision of Chairperson of the Selection Committee shall be final.
